FPH 2018 DARE Lecture

A post-Brexit Food Plan: filling the space vacated by HM Government



We are delighted that Professor Tim Lang has kindly joined us today for this year's DARE lecture. Tim is professor of food policy at City, University of London's Centre for Food Policy. His interest in food (as a link to health, environment, culture and political economy) started when he was a hill farmer in Lancashire in the 1970s. This was the foundation of his work in the 1980s, first academically, then in the public sector and civil society, and for the last quarter century back in academia.

Tim was a food advisor to the EU Environment Commissioner (1988), food commissioner on the UK Sustainable Development Commission (2006-11), and a member of UK Council of Food

Policy Advisors (2008-10) and the London Food Board advising the Mayor of London (since 2009, reappointed 2017).

He is an author and co-author of numerous journal articles and ten books. His latest book is Sustainable Diets (with Pamela Mason), published in March 2017. His current book is on the state and future of the UK food system. Tim is a member of the EAT-Lancet Commission on Healthy Diets from Sustainable Food Systems (reporting summer 2018) and was an expert (advisor) to the European Economic & Social Council's Opinion on the case for a comprehensive EU Food Policy (2017).

Also, we are delighted to announce that Professor Debra Salmon will be introducing Professor Tim Lang. Debra has extensive experience in health and public health nursing, FPH cannot think of a better person to start this year's DARE lecture off.

History of the DARE lecture

In 1983 a group of consultants and community physicians, protesting against the divisive pay rise awarded to doctors in the NHS (whilst other health staff had had to battle for a pay award half of that given to doctors) established the 'Doctors' Awards Redistribution Enterprise' (DARE). The charity was initially funded from four year covenants made by these doctors, of the difference between the pay rise they received and that which they would have had, if they had been treated the same as other NHS staff. The DARE lecture is the legacy from this work and aims to challenge and stimulate debate on developments within the NHS.
